

## *KICKS 96 CODEWORD CASHOUT CONTEST RULES*

### 1. CONCEPT:

- a) To participate in the KICKS 96 Codeword Cashout Contest, listeners must listen to KICKS 96 for announced CODEWORDS throughout the day during the contest period: May 4 – June 26. There will be eight (8) different CODEWORDS announced each weekday and two (2) additional CODEWORDS announced on Saturday and two (2) additional CODEWORDS announced on Sunday during the contest period.
- b) To enter, listeners must visit [kicks96.com](http://kicks96.com), access the Kicks Country Club, and either log in or register for an account. Participants must then enter the announced CODEWORD and complete the official online entry form.
- c) Only entries submitted with a valid CODEWORD and completed registration information will be eligible for prize drawings. Incomplete, inaccurate, or blank entries may be disqualified at the sole discretion of WQLK-FM and Brewer Broadcasting Corporation.
- d) Codeword entries may be sent to 2626 Tingler Road W. Richmond, IN 47374 by mail if an individual is unable to access the website. Physical entries must contain First and Last Name, Date of Birth, Phone number, and the codeword(s) WITH the time and day it was heard.
- e) The KICKS 96 Codeword Cashout Contest will run beginning May 4, 2026, through June 29, 2026, unless otherwise modified, extended, or terminated by the Station.
- f) One winner will be drawn each Friday during the contest period from all eligible entries received that week, for 8 consecutive weeks.
- g) ONE WINNER PER HOUSEHOLD. A weekly winner's immediate family or household members who are living at the same address are ineligible to win a weekly prize. (The immediate family is defined as a person's parents, siblings, spouse, and children. Households are defined as people living at the same address.)
- h) One (1) Grand Prize winner will be selected on June 29, 2026, from all eligible entries received during the entire contest period.

### 2. PRIZE:

- a) Weekly Prize: The weekly winner will receive ninety-six dollars (\$96). (8 total winners)
- b) Grand Prize: One (1) Grand Prize winner will receive nine hundred sixty dollars (\$960).
- c) Weekly winners remain eligible for the Grand Prize drawing.

d) All prizes are non-transferable and may not be substituted except at the sole discretion of the Station.

f) A completed W-9 form is required for the Grand Prize winner; however, a 1099 form will only be issued if the person's total winning for the calendar year is \$2000 or more.

a) By participating, contestants waive any claims of liability against sponsors, WQLK-FM, Brewer Broadcasting Corporation, its employees, agents, and affiliates for any personal injury, loss, or damage arising from participation in the contest or acceptance or use of any prize.
